

Business+ Banking - Schedule of Fees and Access Limits

Deposits and Loans effective 1 November 2023

This schedule of Fees and Access limits only applies only to the following accounts:

- Business+
- Business+ Saver
- Business+ Overdraft
- Business+ Loan

BANKING FEES

Monthly Account Fee **FREE**

Exceeding available funds fee **\$0.00**

A fee charged when you exceed the actual balance or authorised limit of your savings account, transaction account, or overdraft facility.

Note: debit interest charges may also apply.

Dishonour fee **\$0.00**

A fee charged where we dishonour a direct debit or PayTo payment for any reason or where a debit presented to us is dishonoured because there aren't enough available funds in your account. This is charged on the day the event occurs or next day.

Foreign Transaction Fee **2.95% of AUD transaction value**

A fee that applies to any withdrawal transaction made with your Debit Mastercard outside Australia

- All transactions made overseas
- All transactions in a currency other than Australian dollars
- All transactions made in Australia where the merchant is located overseas
- All transactions made in Australia where the financial institution or entity processing the transaction is located overseas

Third-party ATM fees **Not ascertainable**

May be charged an upfront fee for withdrawals and balance enquiries when using some ATMs, which will be determined by the third party ATM owner. The fee will be disclosed and charged by the ATM owner at the time of performing the transaction.

LOAN FEES

Establishment Fee **\$495.00**

A one-off fee payable for the establishment of your Loan Account. On the Loan Date, this fee will be added to the Amount Owing.

Overdraft Facility Fee (per month) **\$30.00**

A monthly fee, payable on the last Business Day of the month (this fee is payable even if you have not used your Business+ Overdraft).

Loan Service Fee (per month) **\$20.00**

A monthly fee payable whilst your Business+ Loan Account remains open.

Early Repayment Fee **\$50.00**

A one-off fee payable if the whole or part of your fixed rate loan is repaid early or your Loan Agreement is varied or terminated during a fixed rate period.

This fee will be added to the Amount Owing at the time of early repayment, variation or termination.

Early Payment Cost (EPC) **Unascertainable**

A one-off fee payable if the whole or part of your fixed rate loan is repaid early or your Loan Agreement is varied or terminated during a fixed rate period.

This fee will be added to the Amount Owing at the time of early repayment, variation or termination.
